In response to the increasing evidence of asymptomatic spread of COVID-19 and to reduce the risk of exposure for Houston Fire Department members, Medical Direction has sanctioned the use of cloth masks and surgical masks based on CDC recommendation for the purpose of reducing station contact and member quarantine. The following directives will be in effect for the duration of the community health emergency caused by the COVID- 19 pandemic.

- All members shall wear some form of face covering when in any city facility/fire station, place of business, areas of assembly, and any other area considered a government or public venue. The face covering may be a homemade mask, scarf, bandana, handkerchief, or other mask meeting CDC recommendation or HFD requirements so long as it covers the nose and mouth. This mandate is for all members who are on duty and/or in uniform.
 - This does not replace the use of all appropriate PPE while on EMS calls as directed in General Order#20-106, dated March 26, 2020.
- All HFD employees will practice social distancing (at least 6 feet of separation) ESPECIALLY at times where facemasks are not being worn such as when eating or drinking.
 - Members will consider eating meals in different locations/shifts, adjusting sleeping arrangements, minimize shift change interactions, and not lingering once relieved to allow for appropriate social distancing.

When compliance to the above directives are maintained and a member subsequently becomes symptomatic and tests positive for COVID-19, the recommendation from Medical Direction will be that station members be placed on **self-monitoring** by HFD Infection Control and will NOT require quarantine.

If members do **NOT** wear masks at all times or do **NOT** practice social distancing appropriately at the station, then members at the station may be subject to quarantine if a member tests positive based on Infection Control's assessment of the exposure.

Surgical masks will be delivered to HFD District stations for dissemination and accountability. District Chiefs will utilize HFD Form #293 District Station BSI Order Form for additional PPE. Any questions regarding this order will be addressed through the chain of command.
